These Tier 2 partners are operating in Chikwawa, Neno, Karonga, Phalombe, Zomba, Machinga, Salima¹ and national level where CISONECC advocacy activities are being implemented. The CJC is inherently linked to wider Scottish Government policies including gender and international development with embed principles under the Gender Equality Act 2014 and OECD-DAC Gender Equality Policy Marker. CJC responds to these policies by empowering the most marginalised groups.
